CRIMINAL JUSTICE ALUMNI SURVEY – 2011 Administered to UTM CJ Graduates for the years 2007-2011

A total of 115 Criminal Justice Alumni Surveys were mailed to graduates of the program for each semester from Fall 2007 to Spring 2011; 32 alumni responded, for a response rate of 27.83%. Their responses are highlighted below. Should anyone request a copy of the full data, please contact the UTM Criminal Justice program.

ALUMNI INFORMATION

Twenty-three of 32 respondents attended UTM for all of their education (71.9%) while nine transferred from another institution. Of the nine who entered UTM with some college, six transferred from community colleges and three transferred from another four-year institution.

Males and females were equally represented at 15 respondents each, with two respondents not specifying gender.

African Americans comprised 18.8% of the respondents (n=6), while 23 identified themselves as Caucasian (71.9%), one person identified him/herself as "other" and two did not specify.

Self-identified GPAs ranged from 2.01 to 3.56.

Nine of the 32 respondents noted that they had participated in an internship (28.1%). Five of those students are currently employed in the criminal justice field.

CRIMINAL JUSTICE EMPLOYMENT

Slightly more than 40% of respondents noted that they were currently employed in the Criminal Justice arena (n=13, 40.6%), while 19 noted that they were not currently employed in the criminal justice field (59.4%). This number does not reflect those students who were currently in graduate or law school. One third of those employed in the criminal justice field are working as law enforcement officers (n=6), three are working in corrections, three noted "other", and one noted working in the security field.
