AUDIENCE FOR THIS PROSPECTUS

This document is a review of key projects in Tipton County's Opportunity Zones. It's intended for those interested in taking advantage of the federal legislation or looking for places to put their money.



Local individuals with capital gains: These individuals who just sold a company or a piece of property and have a smaller amount of capital gains that they would rather invest in the local economy than pay federal taxes on. This document shows what's happening in their back yard and what they can do to support it.

The Covington-Tipton County area is an exceptional place to start a business or relocate and existing business for a number of reasons. As a business leader, you rely on strong local leadership to have programs in place that benefit business growth and attract visitors and shoppers to the community. We have two local Chambers of Commerce that work together to serve the entire county.

Nestled between the Mississippi and Hatchie Rivers, Tipton County is a place that families move to for our strong school system. We now need retail and restaurants to follow and provide an atmosphere that causes families to remain here after the children graduate.

Our local businesses have a strong network of supporters through the Chamber of Commerce and also their peers. Just recently, Covington was named a "Smart Start" Community after the chamber staff hosted a training for local stakeholders. Additionally, Covington was just selected to participate in the two-year TN Downtowns program. The downtown businesses even formed an alliance called the Downtown Covington Association that meets each month to plan events that attract visitors to shop and support the Historic Covington Square.

Since our Chamber of Commerce serves as the lead tourism organization for the county, we have the opportunity to plan group tours and receive numerous inquiries about the trips to Covington throughout the year, especially during the spring and summer months. We work well with our state, county, and city leadership to acquire grants and develop programs that ultimately benefit our local business community through economic development. As a result of those efforts, we are proud to share that Tipton County ranks 44 of our 95 counties when it comes to tourism revenue.

Other programs that support business include our Tipton County Government young and growing Workforce Development Program. We aid in those efforts by hosting the TOTAL Youth Leadership program for high school juniors each year. With organizations like the Covington Economic Development Corporation that hosts events and festivals throughout the year in addition to the Chamber hosted Heritage Festival, our community is served well by partnerships of local organizations. We understand that it takes a team effort to develop a community and serve as catalysts to continue the growth that's occurring.


